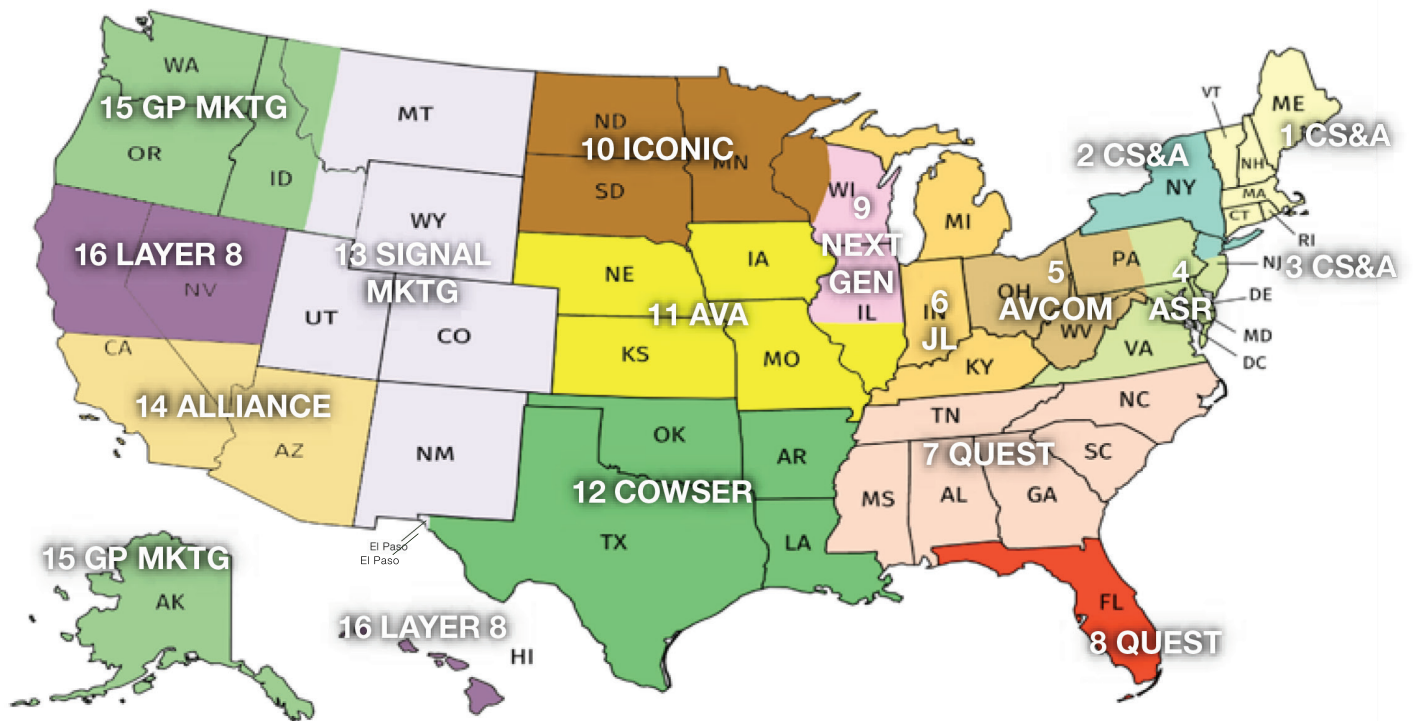


Soundsphere Map
